

Local Law 93 of 2015 (Previously Local Law 6 of 2011) - Biannual Report

Pursuant to Local Law 93 of 2015, the Department of Education is required to provide reports on student discipline data (suspension data) to the City Council twice a year (October 31 and March 31). The March reporting requires citywide suspension data by month for the first half of the academic year, July through December. Per the legislation and in accordance with the Family Educational Rights and Privacy Act or FERPA, any value from zero (0) to five (5) has been redacted.

Data from July – December 2017, when compared to the same time period last year, July – December 2016, shows an increase of 20.9% in total suspensions. Principal suspensions increased by 19.5% and superintendent suspensions increased by 24.7%.

Year to date, as of March 23rd (121 school days), we are seeing an increase of 5.4% in total suspensions with principal suspensions increasing by 4.1% and superintendent suspensions increasing by 8.8%. The increase in suspensions since January has decreased significantly following this reporting period.
