## Local Law 51－Reporting on student－to－student bullying， harassment，intimidation and discrimination

Pursuant to Local Law 51 of 2018，the Department of Education is required to provide reports on student－to－student bullying，harassment，intimidation and discrimination twice a year（May 31 and November 30）．Per the legislation and in accordance with the Family Educational Rights and Privacy Act（FERPA），any value from one（1）to five（5）has been redacted．

The May 31 report pertains to the fall semester of the school year（July 1 －December 31）and contains unaudited data．The Office of Safety and Youth Development reviews potential bullying incidents on a rolling basis to ensure accuracy，but this review process does not conclude prior to May 31．Additionally，some investigations are still in progress and have not yet been completed． Therefore，fall semester data is subject to change．The November 30 report will contain audited data．
