

Local Law 93 of 2015 (Previously Local Law 6 of 2011) - Biannual Report

Pursuant to Local Law 93 of 2015, the Department of Education is required to provide reports on student discipline data (suspension data) to the City Council twice a year (October 31 and March 31). The March reporting requires citywide suspension data by month for the first half of the academic year, July through December. Per the legislation and in accordance with the Family Educational Rights and Privacy Act or FERPA, any value from zero (0) to five (5) has been redacted.

Data from July – December 2016, when compared to the same time period last year, July – December 2015, shows a decrease of 5.7% in total suspensions. Principal suspensions decreased by 4.2% and superintendent suspensions decreased by 9.6%.

Year to date, as of March 17th (114 school days), we are seeing a decrease of 7.5% in total suspensions with principal suspensions decreasing by 6.1% and superintendent suspensions decreasing by 11.1%.

The March reporting requires EMS data disaggregated by district and by month for the first half of the school year (July to December). Per the legislation and in accordance with the Family Educational Rights and Privacy Act or FERPA, any value from zero (0) to five (5) has been redacted.
